Dear Sir / Madam,

A4095 North Leigh – Carriageway Maintenance

I am writing to inform you that Oxfordshire County Council will be undertaking carriageway maintenance work on the A4095 North Leigh between Nursery Road and Boddington Lane.

The works are programmed to start on **Monday 18th July 2022** and are expected to last for up to 4 weeks, subject to any bad weather conditions or unforeseen circumstances arising during construction.

The works will include replacing damaged ironwork, drainage improvements, resurfacing of the existing carriageway and the replacement of road markings.

Traffic Management

To enable these activities to be carried out safely the work will be done in the following phases:

- **Phase 1:** Monday 18th July to Friday 5th August, 07:30 to 16:30hrs temporary traffic signals to enable preparation work to be carried out, including replacing damaged ironwork and drainage improvements.
- **Phase 2:** Monday 8th August to Sunday 14th August, 19:00 to 06:00hrs full road closure to enable the resurfacing work to be carried out and replacement of road markings. A signed diversion route will be put in place during this period.

The A4095 will be reopened to traffic when safe to do so outside of these periods.

Staff will be positioned at either end of the closure to direct traffic and pedestrians to ensure the safety of the public and workforce. We ask that you give them your full support whether you are a pedestrian, cyclist, or motorist.

Every effort will be made to accommodate vehicular access to properties and businesses within and adjacent to the works, but this may be subject to some delay depending on the activities being carried out on site. Again, I ask for your support during these periods. We have consulted with West Oxfordshire District Council's Environmental department regarding carrying out these works at night. As part of this consultation the noisier operations, i.e. removing the existing carriageway and breaking out, will cease by 11pm. Unfortunately, the remaining operations are not completely silent, but the site team will be briefed to complete the work with as little disruption and as quietly as practicably possible.

Keeping You Informed

Several methods of communication are being used to keep you informed of these works:

- Signs are being placed on site to forewarn road users in advance of the works.
