Dear neighbour,

East End – 20 mph speed limit.

As you may be aware Oxfordshire County Council have recently approved an £8 million budget for a three-year programme to support the implementation of 20 mph roads across Oxfordshire. Following this approval our County Councillor, Liam Walker, carried out a survey across his ward in order to try and determine which communities were in favour of introducing 20 mph speed limits. While the overall number of responses received from parishioners was disappointingly low, the majority of those in North Leigh village who did respond were in favour of introducing a 20 mph speed limit throughout the village and those residents of East End who did respond supported the 30 mph limit being reduced to 20 mph. The parish council has therefore requested that East End and North Leigh be included in the proposed plan.

provides further details of the scheme and the criteria that must be met in order to qualify for inclusion.

If we are accepted into the scheme OCC will provide the funds to replace the 30 mph signs with 20 mph signs. However, it is important to note that there will no additional monies to resource traffic calming measures, including electronic speed indicator devices (SIDs) or increased enforcement action, such as speed cameras.

The next step in the process is for the parish council to canvass the residents of East End to see if there is a majority of residents in favour of reducing the existing 30 mph limit to 20 mph.

As a separate initiative the parish council is also looking at the possibility of installing SIDs or vehicle activated signs (VAS) at both ends of East End in order to try and reduce traffic speeds. While the two proposals are independent of each other they could be linked together should the opportunity arise.
