Are you on the Parish electoral register for the Parish of North Leigh?	
Have you lived in the Parish of North Leigh, or within 3 miles of its boundary, for at least a year?	
Have you been the owner or tenant of land or other premises in the Parish of North Leigh for at least a year?	
Have you had your principal or only place of work in the Parish of North Leigh for at least a year?

Are you the subject of a bankruptcy restriction order or interim order?	Yes / No
