ABOUT COMMUNITY FIRST OXFORDSHIRE

Community First Oxfordshire (CFO) is a community development charity. We support social action projects, volunteering, community halls, transport schemes and local businesses. We also run a placemaking and town planning consultancy, helping communities and clients, including parish and town councils, Local Authorities, and developers to identify planning and infrastructure requirements and develop the policies and projects necessary to achieve them.

NORTH LEIGH NEIGHBOURHOOD PLAN

Neighbourhood planning is a right for communities introduced through the Localism Act, 2011.

Neighbourhood plans are legally binding planning documents. They must comply with both local and national, higher-level planning policies, and they are about allowing villages, towns or neighbourhoods to shape development in that area. A final NP is a set of policies related to land use, identifying what is best for the locality and what is needed to deliver tangible changes to that place.

In 2023, North Leigh Parish agreed to develop a Neighbourhood Plan (NP).

The Steering Committee has commissioned Community First Oxfordshire to support the development of the NP.

145 local residents attended a launch event in February 2024. The main themes discussed were:

- INFRASTRUCTURE
 - Topics included: roads, traffic, sewage, transport, employment.
- HOUSING DEVELOPMENT
 - Topics included new development, local character, design.
- AMENITIES
 - Topics included: pubs, shops, post office, church.
- RECREATION
 - Topics included paths, halls, rights of way, playgrounds.
- GREEN SPACES
 - Topics included views, woodland, green spaces, Roman villas, North Leigh common.

THE NEIGHBOURHOOD PLAN SURVEY - SUMMER 2024

A survey is one of the key means of finding out what residents think about a range of issues. The survey is an important part of the evidence base underpinning the Neighbourhood Plan, with the findings helping guide the next stage of plan-making.

The intent of the Neighbourhood Plan Survey was to further explore the themes discussed at the February launch event (and other topics). The questions were developed by the Steering Committee, supported and advised by CFO.

DISTRIBUTION AND RESPONSE

In order to carry out the Community Survey, a printed survey and *Freepost* return envelope were delivered to 970 households in North Leigh by members of the NP Steering Committee in June 2024.

Residents were invited to respond to the Community Survey by either returning a completed hard copy survey or accessing a *Survey Monkey* internet link. The survey deadline was 28 July 2024.

CFO analysed the survey returns and produced this report.

362 survey responses were received (37% response rate)






1. Please tell us where you live. TOTAL RESPONDENTS = 358




2. How many people of each age group live in your household? TOTAL RESPONDENTS = 356 (845 INDIVIDUALS)



3. Please tell us how many cars your household has. TOTAL RESPONDENTS = 359




4. How many people in your household commute to work or school? TOTAL RESPONDENTS = 358








8. Would you like to see housing expansion in North Leigh parish result in the parish joining up with Hailey / New Yatt / Hanborough?






11. Would you like to see new housing development in North Leigh parish? TOTAL RESPONDENTS = 355










20. Do you think The Neighbourhood Plan should contain policies to conserve and enhance nature, biodiversity, and wildlife in North Leigh parish?




21. How serious do you consider the following pollution issues, on a scale of 1-5: 1 = not serious at all, 5 = very serious?



22. Do you agree that the following archaeological or historical places and their surroundings should be protected from development? TOTAL RESPONDENTS = 356




23. Do you agree that the following green spaces or public rights of way should be protected from development? TOTAL RESPONDENTS = 354




24. Do you agree that the following woodlands should be protected from development?














46. Would you be willing to be involved in the preparation of North Leigh Neighbourhood Plan?
